MONTHLY PARKING AGREEMENT TERMS & CONDITIONS

1. Monthly payment is due on the first day of each month for that month's rent. If full payment is not received by the 7th of the month, a \$25 late fee will be assessed and monthly parking privileges can be revoked.
2. Parking rates are subject to change by Park Kwik LLC upon one calendar months' notice.
3. Park Kwik LLC may modify or terminate this monthly parking agreement upon one calendar months' notice. Further, if in breach of the terms and conditions of this monthly parking agreement, Park Kwik LLC may, without notice, suspend parking privileges, terminate the monthly parking agreement and tow the vehicle at the owner's expense.
4. You may terminate the monthly parking agreement upon one full calendar month's **written** notice. Notice given at any time during a month will be effective as of the last day of the following month.
5. At all times a valid permit must be visibly displayed with the account number facing the windshield (except if no permit had been issued). Failure to do so will be considered a breach of the monthly parking agreement. Permits are only valid for the parking facility for which they are designated.
6. Parking charges for self-park locations are for the licensed use of parking spaces only and Park Kwik LLC is not responsible for any loss or damage to your vehicle or its contents.
7. The parking of unlicensed or uninsured vehicles, the general storage of vehicles, and the repair or maintenance of vehicles is prohibited. Further, the parking of vehicles that (at the discretion of Park Kwik LLC) pose any kind of hazard or have hazardous contents is also prohibited.
8. You may not assign or transfer your monthly parking agreement or privileges, unless agreed on by Park Kwik LLC.
9. Park Kwik LLC is not responsible for any personal property or articles left in vehicle.
10. Park Kwik LLC is not responsible for any mechanical failure.
11. Limit of liability is \$25,000 per vehicle.
12. Any additional terms and conditions (except parking rates) displayed on the signage at the parking facility must be observed.
