MONTHLY BIKE AGREEMENT TERMS & CONDITIONS

1. Payment is due on the first day of the month for that month's rent charge. If the full payment has not been received by the seventh day, a \$10 late fee will be billed per bike on the account and monthly storage privileges can be revoked.
2. Payment is for the monthly use of the bike storage space only and Park Kwik LLC is not responsible for any loss or damage to the bike, its contents, or articles left nearby.
3. Storage rates are subject to change by Park Kwik LLC upon a one month's notice.
4. Terminations of the monthly bike agreement are effective upon a one month's **written** notice. And any notification given during the month will be effective as of the last day of the following month.
5. Park Kwik LLC may modify or terminate this monthly bike agreement upon a one month's notice. If in breach of the terms and conditions of this monthly bike agreement, Park Kwik LLC may, without notice, suspend storage privileges, terminate the monthly bike agreement and remove the bike at the owner's expense.
6. A valid permit must be visibly displayed with the account number at all times (except if no permit has been issued). Permits are only valid for the facility in which they are designated.
7. The reassignment or transfer of a monthly bike agreement and its privileges is restricted unless agreed upon by Park Kwik LLC.
8. Any additional terms and conditions displayed on the signage at the facility (except the rates) must be observed.
